2. *No Objection Certificate (NOC)* from the employer (only for in-service candidates). In case the NOC has not been uploaded at the time of joining and some relaxation in time limit is needed for submitting the Certificate due to COVID situation, request along with evidence of application submitted for NOC may be placed dps@mlsu.ac.in with copy of the mail to the respective Head of the Department.
3. *Undertaking* as given in Annexure-I.
4. *Transfer Certificate* if last degree has been qualified from a college other than University Constituent Colleges including any other affiliated college under MLSU, Udaipur.
5. Joining Report and Course Work Registration Form duly forwarded by the supervisor and Head of the Department (Digital signatures will be accepted).

The subject of the mail sent must be given as "**Your name_ref mail dated31.05.2021_name of supervisor_name of department**".
